3.1. BCTBID OPERATIONS AND MANAGEMENT: UPDATE BYLAWS (Nichole Farley)

At the request of Supervisor Teeter—and in light of the BCTBID Owners Association's proposal to include short-term vacation rentals (STVRs) in the District—the Board of Supervisors has requested that Explore Butte County include STVR representation on its Board of Directors. Accordingly, the Bylaws have been amended to add two STVR representatives, move the Annual Meeting from March to September, and update the officer titles from President and Vice-President to Chair and Vice-Chair, respectively.

The Resolution of Intent to Modify the BCTBID was adopted on May 13, 2025. A Public Meeting was held on June 10, 2025. The final Public Hearing is on July 29, 2025.

As of July 15, 2025, the Clerk of the Board has received written protests representing less than 0.10% of the total projected assessment revenue and fewer than 0.25% of the lodging units in Butte County. In contrast, written support for the proposed BCTBID modifications has been received from businesses representing over 30% of the total projected assessment revenue and more than 39% of the available lodging units in the county.
